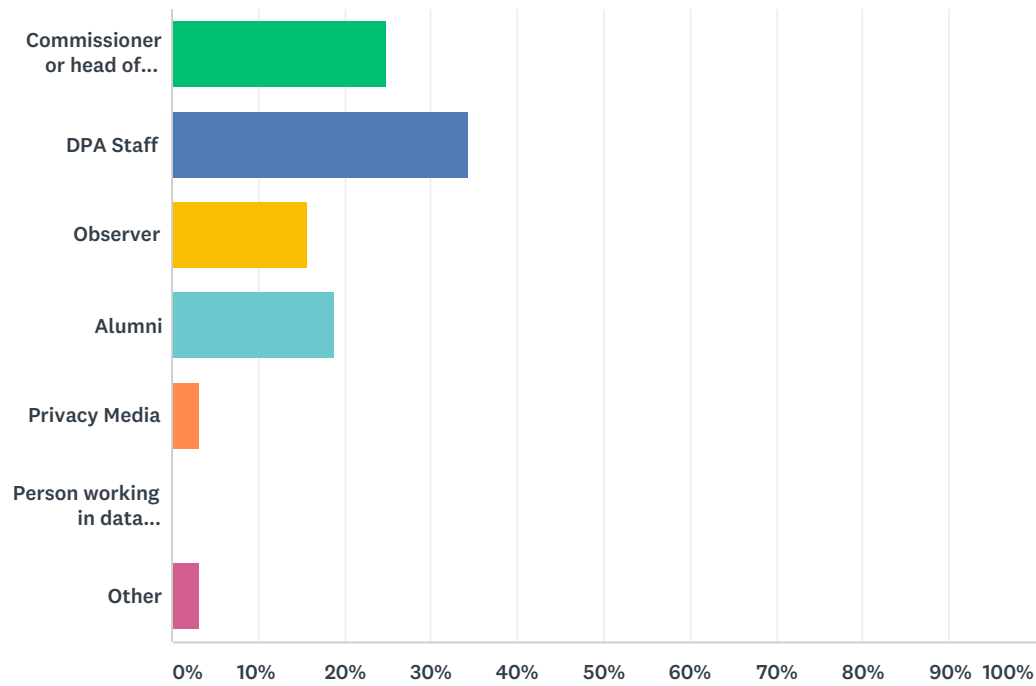


Q1 About you Please indicate whether you fall in one of the following categories

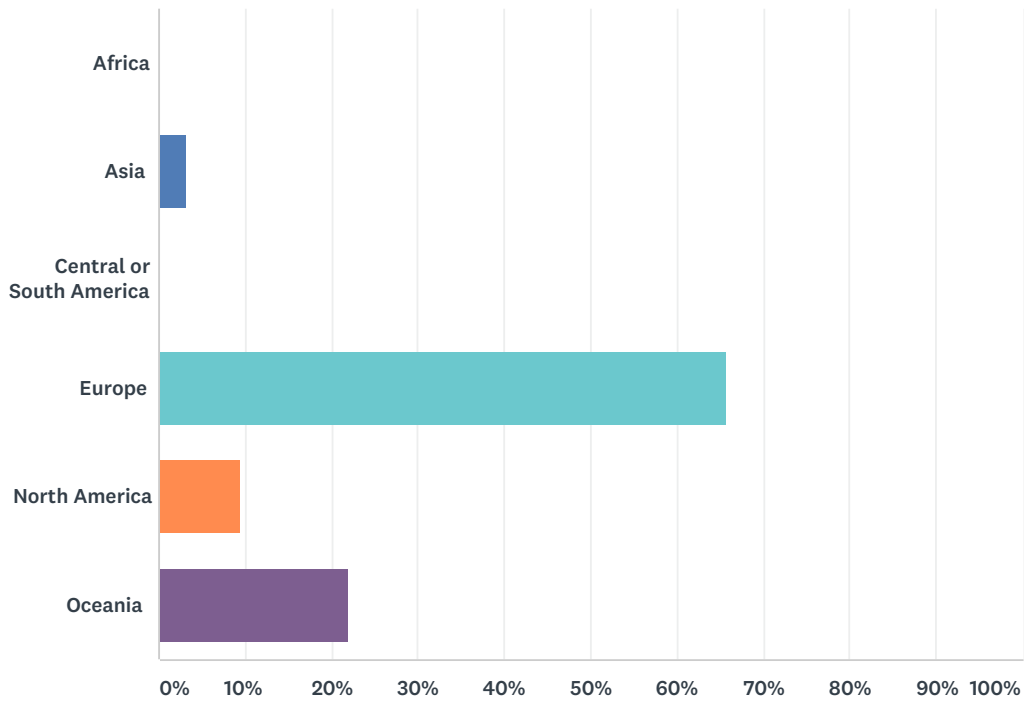

Q2 Where are you from? Please indicate your region

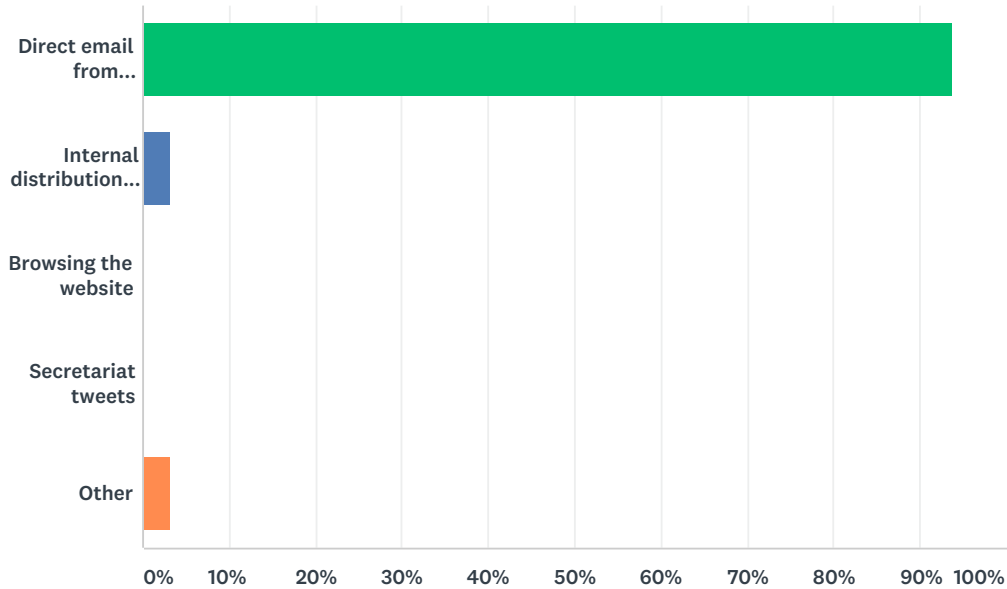

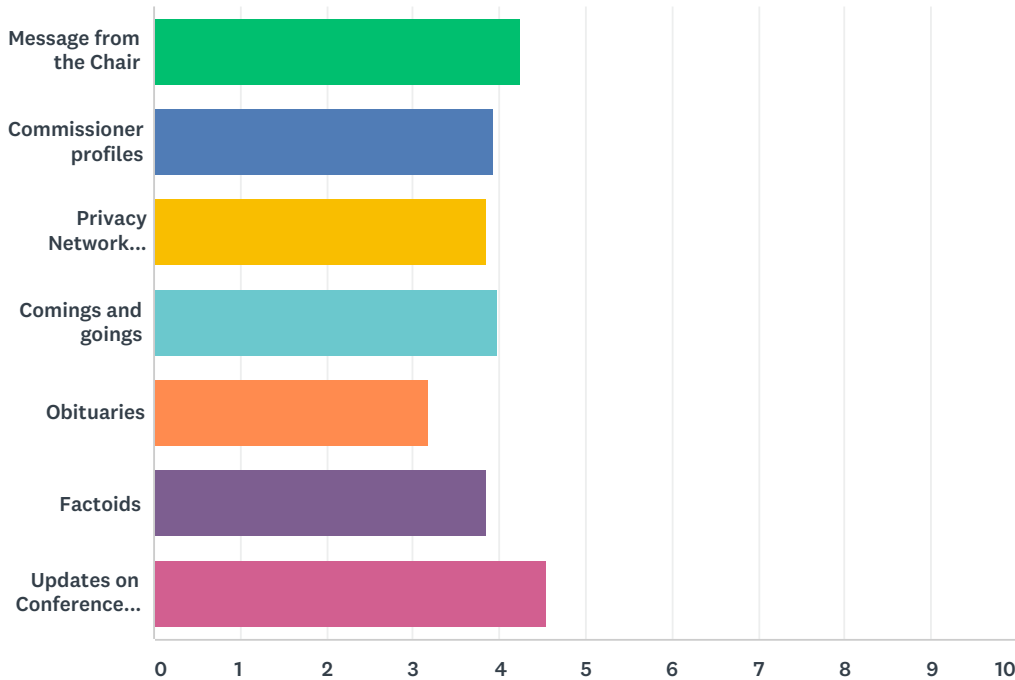
