The Notifiable Data Breaches Scheme 12-month Insights report draws together detailed statistics and lessons learned during the first year of mandatory reporting in Australia to highlight the causes of data breaches and how to prevent them.

Launched by the Office of the Australian Information Commissioner for Privacy Awareness Week 2019, the report has driven widespread media coverage and analysis about the operation of the scheme, raising its visibility to the general public and regulated entities.

The Notifiable Data Breaches Scheme 12-month Insights report draws together detailed statistics and lessons learned during the first year of mandatory reporting in Australia to highlight the causes of data breaches and how to prevent them.

Launched by the Office of the Australian Information Commissioner (OAIC) for Privacy Awareness Week 2019, the report has driven widespread media coverage and analysis about data breaches, raising visibility of their causes amongst the general public and regulated entities. It is the culmination of 12 months of quarterly reporting on notifications received, supplemented by detailed trend data, expert analysis, case studies and best practice recommendations.

The Insights Report shows 964 eligible data breaches were reported under the scheme from April 2018 to March 2019. Malicious or criminal attack caused 60% of data breaches, including 153 incidents linked to phishing. Human error caused 35% of data breaches and 5% were due to a system fault. Most breaches were reported in the health sector, followed by the finance sector.

By improving awareness and understanding of these issues, the OAIC is assisting organisations covered by Australia's national privacy law to implement changes that will reduce the risk of data breaches in the future. The Insights Report also provides an important source of information to cyber security professionals and privacy practitioners, to inform their advice on measures to prevent data breaches.

The OAIC's reporting on the scheme has supported ongoing media coverage of data breaches, leading to greater consumer awareness of privacy rights and risks amongst consumers. The proactive measures people can take to protect themselves from data breaches, and what to do when notified about a data breach, have been a focus of the OAIC's communications.

The Insights Report arms organisations with greater knowledge about how to prevent, detect and remedy data breaches. Through this initiative, the OAIC is helping to deliver on the purpose of the scheme: to protect consumers by elevating the security posture across the economy, and increasing transparent and accountable personal information handling practices.

Through publication and promotion of the Notifiable Data Breaches Scheme 12-month Insights Report, the Office of the Australian Information Commissioner has lifted the profile of privacy across the Australian jurisdiction and elevated data breaches to a board-level risk.

The report provides a clear evidence base and practical, proactive measures that can be put into practice immediately by business and government agencies. The OAIC's approach to reporting also strikes the appropriate balance in providing visibility of data breaches without deterring organisations from notifying.

The Insights Report provides a roadmap for improving privacy practice and data protection for stakeholders across the wide range of entities we regulate, from small business owners to company directors.

Through the ICDPPC and other global forums, the Report is also assisting the OAIC to engage with our international counterparts about the causes of data breaches, to support cross-jurisdictional insights. This supports greater collaboration on ways to evolve towards global policy, standards and models for data protection and privacy, in line with the ICDPPC's strategic goals.
