Our Young Privacy Ambassador Programme is a series of information awareness sessions, delivered by JOIC staff to equip young people in our jurisdiction with the necessary skills to become 'Mini Information Commissioners'.

Our rolling progressive programme contributes to the Jersey school citizenship curriculum. Students get involved in considering how their decisions and choices can affect their individual rights and responsibilities as they grow up into adulthood. Our sessions also have the benefit of helping to develop employability whilst learning about the economic and business environment.

This academic year we explored privacy with 25% of secondary school students in Jersey aged between 11 and 16. Our annual, aggregated programme, with dates already scheduled for the next academic year, means cumulatively, the students' knowledge will be embellished year on year throughout their school life.

Our bespoke sessions are highly interactive with games, quizzes and lively debate to explore;

- Privacy and why it matters
- Personal information rights
- Where and how data protection fits into their worlds

Our entire team is involved in presenting directly to the students. We continually strive to improve our student engagement skills with fresh ideas and tactics, to this end we are undertaking some tailored specialist 'teacher training'. We always ask for student and teacher feedback to keep us on the ball and to improve our offering.

One teacher offered this testimonial:

*"The Jersey Office of the Information Commissioner is providing lesson delivery for our year 10 and year 11 students to assist our young people's understanding of legislation surrounding data protection which is equipping them with the tools to ask questions of others who are requesting their data. Next academic year both the International Baccalaureate and A-Level students are with us to explore what privacy and data protection means for them. These students are developing material for the JOIC website to help inform other young people about their rights."*

The next phase of our programme is to engage with key stage 2 students (aged between 7 and 11) with a data protection mascot, activity packs and parental information.

We believe our 'Mini Information Commissioner' concept deserves recognition because;

- We tackle privacy issues with our Island's young people who grapple to understand the relevance and significance in the face of burgeoning social media.
- We impart resilience in the face of increasingly sophisticated scams and fraudulent activities.
- It is vitally important to help young people to safeguard their rights and freedoms.
- We are nurturing privacy ambassadors for future generations.
- Jersey prides itself as a well-regulated jurisdiction and our programme is instrumental in protecting Jersey's strong reputation as a safe place to live and do business.

With adults and especially children now living their lives online, we recognise children need particular 'education/guidance' when their personal data is being collected and processed because they may be less aware of the risks involved.

We believe our efforts to collaborate with Jersey's younger generation and our local education authority to affect the lives of thousands of people in our jurisdiction deserve to be recognised. As our chair, Jacob Kohnstamm says:

*"It is not enough that the different players perform their individual roles. The more impressive results happen when we all work well together. Good data protection is a journey not a destination."*
