"Contact Tracing & the Apple & Google solution. In conversation with the technical specialists."

As countries begin to ease their Coronavirus (COVID-19) restrictions, data protection and privacy authorities across the world are faced with a fundamental question: how can we enable governments' responses to the pandemic and subsequent recovery whilst continuing to protect citizens' personal data and privacy?

Recognising this challenge, the GPA Executive Committee established a COVID-19 Taskforce to drive practical responses to privacy issues emerging from the pandemic, as well as to assist its membership with insight, best practice and the delivery of capacity building activities, including through collaboration with relevant GPA networks and stakeholders.

A key output of the Taskforce is our Webinar Series that seeks to address some of the critical issues facing the data protection and privacy community, thereby enabling capacity building for the GPA membership community.

In April this year, Apple and Google announced a joint initiative on contact tracing technology to support the efforts of governments and public health authorities in containing the spread of COVID-19. In this first GPA Webinar, technical experts from Apple and Google will present their contact tracing framework and engage in a structured conversation with a selected small group of technical experts from data protection and privacy authorities. The panel will discuss the development and functioning of the API technology and the steps taken to safeguard users' privacy.

Taskforce members will have an opportunity to flag in advance some of the themes they would like the panel to address. It is hoped that this session may be particularly helpful for members and observers whose countries are at the exploratory or decision-making stage of the process on the adoption/roll out of contact tracing applications.
