- Log in to the CIRCABC platform by clicking on “Connect using ECAS” at <https://circabc.europa.eu> and enter your ECAS username and password.

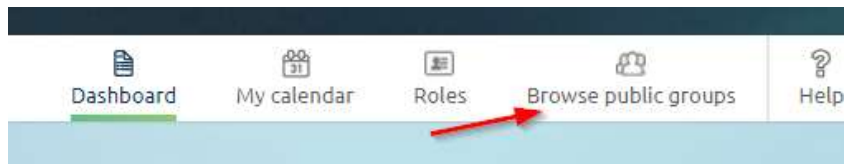
