The Info Matters podcast dives into conversations with people from all walks of life about the access and privacy issues that matter most to them. Hosted by Ontario's Information and Privacy Commissioner, Info Matters invites special guests to share their perspectives, stories, and facts in an accessible way that helps listeners understand real-world issues in access and privacy. Info Matters builds on our office's strong legacy of public outreach and education, providing useful information in a freely available and easy to understand format.

#### **b.** Please provide a full description of the initiative (no more than 350 words)

In 2021, the Office of the Information and Privacy Commissioner of Ontario (IPC) expanded its outreach efforts and hit the digital airwaves, launching *Info Matters*, a podcast about people, privacy, and access to information.

Podcasts are a highly popular form of communications. It's estimated that <u>more than half</u> of Canadians over the age of 18 have listened to a podcast. This medium provides an ideal opportunity for the IPC to extend its direct reach to audiences, building visibility and familiarity with stakeholders, including the general public, in a way that isn't possible through written documents or other means.

As host, Commissioner Patricia Kosseim welcomes guests who speak about everything from avoiding online phishing scams to navigating the ins and outs of digital health technologies and talking to kids about privacy. Now in its second successful season, the podcast continues to provide timely, in-demand information on the privacy and access issues that Ontarians care most about.

With listeners from across Canada and around the world, *Info Matters* is available on all major podcast streaming services. Our growing audience can listen to interesting episodes anytime, anywhere! A number of these episodes are dedicated to the <u>four strategic</u> <u>priorities</u> that guide our office's work in advancing Ontarians' privacy and access rights. Among the most popular: <u>Demystifying the FOI Process</u>, <u>Don't get caught! Protect yourself against phishing</u>, <u>First Nations data sovereignty</u>, <u>Putting patient trust at the centre of virtual health</u>, and <u>Teaching kids about privacy</u>.

From seniors to parents and teachers, children and youth to healthcare workers, Franco-Ontarians and culturally diverse communities across the province, everyone's invited to take part in the conversation.

# c. Please explain why you think the initiative deserves to be recognised by an award (no more than 200 words)

*Info Matters* has helped put the IPC on the map as a modern and accessible regulator and raise awareness of the everyday relevance of privacy protection to a broader audience.

With 4,700 downloads (as of June 14, 2022), the podcast has reinforced the IPC's reputation as an expert source of information and recognized leader in access and privacy education and guidance. Moreover, this mode of communication has helped us overcome geographical barriers to extend the IPC's reach, opening the door to fascinating conversations with Ontarians from all parts of the province.

*Info Matters* has also inspired offices in <u>other jurisdictions</u> to launch similar podcasts of their own, a testament to the podcast's pioneering success in supporting our stakeholders in a convenient, accessible, and innovative way.
