This project aims to raise awareness of personal data and personal data protection culture among university students.

The Project is designed in stages. Each stage consists of two stages. In the first stage, awareness activities are carried out by informing the candidates of personal data protection volunteers about the protection of personal data. In the second stage, university students who are entitled to become "Personal Data Protection Volunteer" are hosted at the Authority and make presentations about their work on the protection of personal data within the scope of the Project.

Within the scope of the Project, students who received training on topics such as "protection and importance of personal data", "protection of personal data in the field of artificial intelligence ", "block chain for the protection of personal data", "metaverse and personal data" and "personal data security are requested to

- Establish student clubs related to the protection of personal data,
- If there is an existing club, increase its effectiveness by participating,
- Organize seminars, conferences, panels and similar events for the protection of personal data
- Conduct awareness studies
- Establish of a department for the protection of personal data in university libraries

in their universities.
