4. DESCRIPTION OF THE INITIATIVE

a. Please provide a brief summary of the initiative (no more than 75 words)

Since 2022, there is the "Herramienta en línea INAI-EIPDP" (Herramienta en línea de Evaluaciones de Impacto en Materia de Protección de Datos Personales), which is a web application in which the entire process of the procedures related to the impact assessments on the protection of personal data can be elaborated, presented and carried out, provides facilities for online processing, from presentation to conclusion. Currently, it is aimed exclusively at the Mexican public sector.

b. Please provide a full description of the initiative (no more than 350 words)

"Herramienta en línea INAI-EIPDP" is a web application, that allows public institutions at the federal level of Mexico to perform online, at any time and during all days of the year, the preparation, presentation and process of the procedures relating to the impact assessments on the protection of personal data, in this way the processes are managed in a more efficient, easy and digital way, The content and processes are in accordance with Mexican law.

The online tool is integrated into three sections:

- 1) Information portal: It contains general information on the procedures that can be performed in this, mandatory assumptions to make impact assessments, cases of exception, requirements to comply, applicable regulations, frequently asked questions. Information that guides, facilitates, and supports impact assessments.
- 2) Interactive self-assessment questionnaire: Section that allows the public sector to know if it is obliged to submit an impact assessment, if it is in an exception, or if it has doubts, it may submit a formal consultation to INAI, in the same medium.
- 3) Transactional section: Secure communication mechanism that covers the entire process, from the creation of the user, beginning and end of the process of any process in which the procedures of:
 - Consultations on the obligation to prepare and submit an impact assessment.
 - Submission of an impact assessment
 - Submission of an impact assessment exception report.

The implementation of this technological tool is the result of efforts to encourage and facilitate public sector controllers at the federal level to carry out best practices in this area, with the aim of reducing risks in the processing of personal data and assisting in the fulfilment of their obligations in the field of protection of personal data; in addition, the information is concentrated in a single place which allows greater control and follow-up of the procedures in a digital form.


c. Please explain why you think the initiative deserves to be recognised by an award (no more than 200 words)


"Herramienta en línea INAI-EIPDP" was developed from the needs that arose from the health emergency caused by the Covid-19 pandemic; a situation which has strengthened the digitization of impact assessment processes, has contributed to the promotion of technological means and the presentation of such preventive actions, optimize and make efficient processes inside and outside the institution, in a growing digital context.

It also promotes compliance with the personal data protection standard by data controllers and encourages best practices, specifically impact assessments on the protection of personal data and accountability for such compliance.

The technological tool proposed today seeks to become not only a secure mechanism for the processing of procedures relating to impact assessments on the protection of personal data, but it is expected to be scalable to incorporate new functionalities and make use of other digital mechanisms.
